

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### **Elderly and Disabled Waiver (E&D) Rate Increase and Incentive Program**

Effective for the Elderly and Disabled Waiver on July 1, 2014 and after, and subject to payment at fee-for-service rates, the Department, in response to a joint federal and state initiative to increase access to care, is proposing an increase in rates for Enhanced Case Management, Alternative Living Services, and Personal Support Services and to implement a provider quality incentive fee program.

The rate increase for Personal Support Services and Alternative Living Services is funded through the third quarter of SFY 2016 via the Balancing Incentives Payment Program in which Georgia receives an enhanced match to augment home and community based services. There is no state impact until fourth quarter SFY 2016. The rate increase for Enhanced Case Management is funded through a legislative appropriation approved in the Governor’s budget in May 2014.

The following rates are proposed to change:

<b>Service</b>	<b>Rate Prior to 7/1/14</b>	<b>Rate Post 7/1/14</b>
<b>Enhanced Case Management</b>	\$175.00 per month	\$183.75 per month
<b>Personal Support Service</b>	\$9.47 per unit	\$ 9.94 per unit
<b>Personal Support Service Extended</b>	\$8.41 per unit	\$ 8.83 per unit
<b>Alternative Living Services</b>	\$35.04 per day	\$36.79 per day

Additionally, the Department intends to implement a tiered add-on provider quality incentive payment of up to 3% for outcomes achieved by eligible enhanced case management agencies. This quality incentive will be added to the enhanced case management monthly unit rate for all qualified providers beginning April 1, 2014. The quality incentive is earned by a combination of baseline quality measures, program measures, and consumer measures.

This change is estimated to increase expenditures as follows:
