

## PUBLIC NOTICE

### **Reinstatement of the Aged, Blind, and Disabled Nursing Home and Institutionalized Hospice Medically Needy Medicaid Coverage Program in the Medicaid State Plan**

Pursuant to House Bill 744 from the 2014 legislative session and effective on and after July 1, 2014, the Department hereby notifies the public that it intends to submit a Medicaid State Plan Amendment to the Centers for Medicare and Medicaid Services (CMS). This State Plan Amendment will reinstate the Aged, Blind, and Disabled Nursing Home and Institutionalized Hospice Medically Needy (“Adult Medically Needy”) Medicaid coverage program and remove the use of Qualified Income Trusts (QIT).

As of July 1, 2014, Georgia Medicaid will transition from establishing financial eligibility for nursing home and institutional hospice from the use of a Qualified Income Trust to an Adult Medically Needy process. Aged, Blind, and Disabled Adult Medically Needy Nursing Home and Institutionalized Hospice classes of assistance will continue to provide Medicaid coverage for individuals whose income exceeds the limit for Nursing Home or Institutionalized Hospice Medicaid class of assistance. Individuals who fall within this class of assistance must incur medical expenses in an amount that is sufficient to reduce their income below the income level established by the State. As of July 1, 2014, Georgia will no longer establish financial eligibility for this Medicaid class of assistance through use of a Qualified Income Trust. This change will not increase annual aggregate State expenditures.

An opportunity for public comment will be held on **June 23, 2014, at 10:30 a.m.**, at the Department of Community Health (2 Peachtree Street, N.W., Atlanta, Georgia 30303) in the 5<sup>th</sup> Floor Board Room. The Board will vote on the proposed change at the Board meeting to be held at **10:30 a.m.** at the Department of Community Health (2 Peachtree Street, N.W., Atlanta, Georgia 30303) in the 5<sup>th</sup> Floor Board Room.
