Learn About the Upcoming Transition into Georgia Families 360°_{SM}

Informational Town Halls for Transition to Care Management of Children in Foster Care, Children Receiving Adoption Assistance and Youth in the Juvenile Justice System

On March 3, 2014, the Georgia Department of Community Health (DCH) is transitioning 27,000 children, youth and young adults in foster care, children and youth receiving adoption assistance, plus certain youth in the juvenile justice system into Georgia Families 360°_{SM} managed care.

Care for these members will be coordinated through Amerigroup, one of the three Care Management Organizations (CMOs) contracted by DCH to serve Medicaid and PeachCare for Kids[®] members as part of Georgia Families.[®]

During February, Amerigroup is conducting informational town hall sessions for health care providers,

foster and adoptive parents, caregivers, Medicaid members and advocates to be held across the state in Atlanta, Augusta, Columbus, Macon, Rome, Savannah and Valdosta.

Representatives from Amerigroup will explain the new program and answer questions. Mark your calendar for these informational sessions for health care providers (11 a.m. to 12:30 p.m.) and parents, caregivers, members and advocates (1 to 2:30 p.m., except as noted below).
