The following revisions are being made to the subject Request for Proposals:

1. Add the following sections to the RFQ after the Introductory paragraph:

Website Specifications:

A. The purpose of the website will be as follows:

- provide information about TAKE Project activities and services;
- provide grant and funding information for TAKE Project participants;
- provide minority specific data for the entire State of Georgia and the five (5) regions of the State where Regional Minority Health Networks have been established;
- provide a calendar of meetings and events; and
- provide for site visitors to contact the project staff and sign up for the project's list serve and other services.

B. Security - The website will not contain any security requirements. The site will be exactly like the project's part of the current DCH website. To view this site go to www.dch.state.ga.us; select, under Divisions and Offices, "Office of Minority Health," "HIV/AIDS TAKE Project."

C. Users and General Information - The users will be persons who have worked with the Project during the past six (6) years, including the fund source, the Federal Office of Minority Health. The site will provide updates on Project activities, funding announcement, meeting announcements, Project newsletter, minority specific HIV/AIDS data for the State of Georgia and the five (5) health districts we have establish our Regional Minority Health Networks in.

The Office of Minority Health's (OMH) primary need for this site is due to technological limitations and the need to count website hits for our Progress Report. OMH will provide all of the information to be placed on the site.

Graphics will be limited mostly to the Project logo and a few pictures from trainings and events conducted by OMH. OMH would like to be able to have guest to the site sign up for a list serve in order that information may be forwarded to them. The site must totally stand alone with a link provided to the DCH website if additional information about the Department and OMH or both is desired.

2. Delete the due date of June 8, 2005, and replace it with the due date of June 30, 2005. The time remains the same.

3. Delete the price range of \$10,000 to \$49,999 and replace it with \$5,000 to \$9,999.

All other requirements remain the same.
