## **Community Behavioral Health Rehabilitative Services**

Effective for services provided on and after September 1, 2011<sup>1</sup>, and subject to payment at feefor -service rates, the Department is proposing to make changes to Medicaid services available through the Community Behavioral Health Rehabilitative Services (formerly called the Community Mental Health Services).

The purpose of the proposed change is to enhance the scope and depth of behavioral health services to eligible members. The proposed amendment incorporates changes necessary for the State's Department of Justice Settlement Agreement and also changes the name of the Operating Agency from the Department of Human Resources to the Department of Behavioral Health and Developmental Disabilities. Specific key elements of the amendment include the addition of the following services:

- Case Management
- Community Living Supports
- Employment Rehabilitation

Community Behavioral Health Rehabilitative Services will continue to be funded through Federal Financial Participation from Medicaid with state match furnished by the Department of Behavioral Health and Developmental Disabilities. The rates for the new services are attached.
