


iPad Sweepstakes

for eligible State Health Benefit Plan (SHBP) members:

- 25 iPads will be awarded monthly (for February 2013–May 2013) to eligible members who complete the on line Health Assessment with all biometric screening measures reported.
- Your Health Assessment must include all biometric measures. Health Assessments completed with “I don’t know” will *not* be eligible.
- If you previously completed your Health Assessment but did not include your biometric measures you may become eligible by updating your Health Assessment with the biometric measures reported and resubmitting.



Eligible Members:

Covered members and former members and their covered spouses (18 and older) who are enrolled in one of the following 2013 SHBP Wellness Plan Options: Cigna Choice Fund® OA Plus (HRA), OA Plus In Network (HMO), Open Access Plus (HDHP) administered by Cigna.

Note: Dependent children and Standard Plan Option and Medicare Advantage enrollees are *not* eligible.

How to Enter the completed Health Assessment Sweepstakes:

Unless they opt out by sending an email to SHBP@Cigna.com, eligible members will be automatically entered when they complete the Health Assessment on www.myCigna.com on or between January 1, 2013 and May 15, 2013. Health Assessments must be complete with biometric screening results (Blood Pressure, Cholesterol, Glucose and BMI).

Drawings:

Timing and prizes for incentives will be communicated via letter/card to eligible SHBP members. Prize winners will be randomly drawn approximately four weeks after the end of each incentive period. Drawing prizes will be awarded approximately six weeks after the end of each month from February 2013–May 2013. Winners will be notified via a mailed letter along with a sweepstakes agreement form from Cigna.
