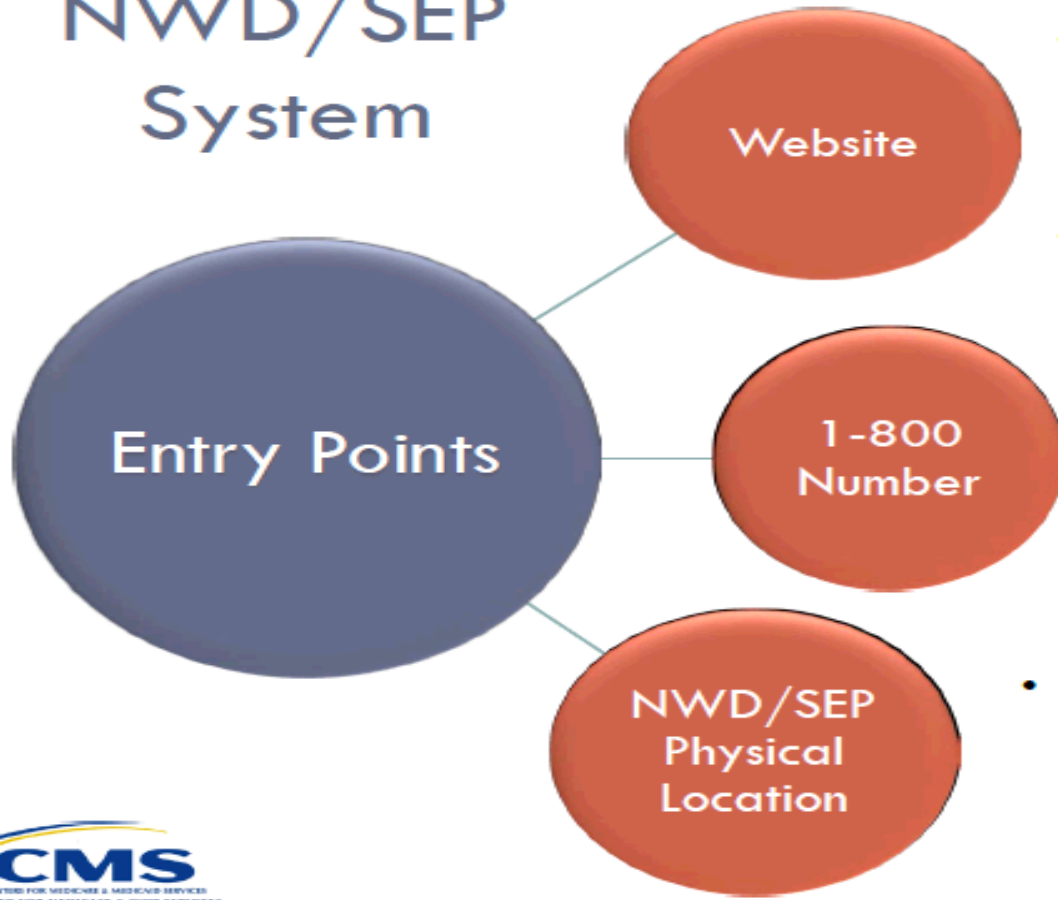

CMS Concept of NWD/SEP

NWD/SEP System



- Contains information about community LTSS, 1-800 number, and location of NWD/SEPs
- Ideally, provides Level I self-screen
- Links individual to a NWD/SEP for information and Level I screen
- Staff conduct Level I screen and coordinate Level II assessment



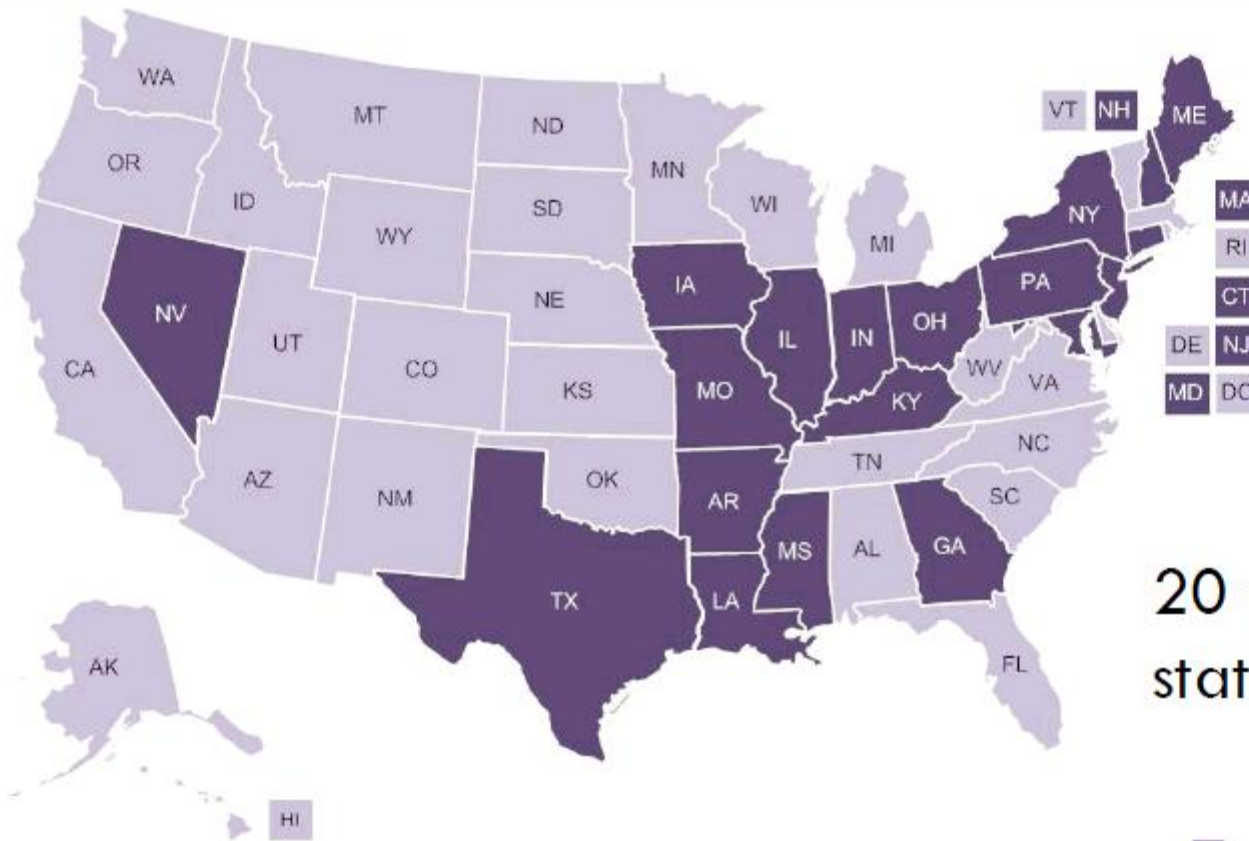

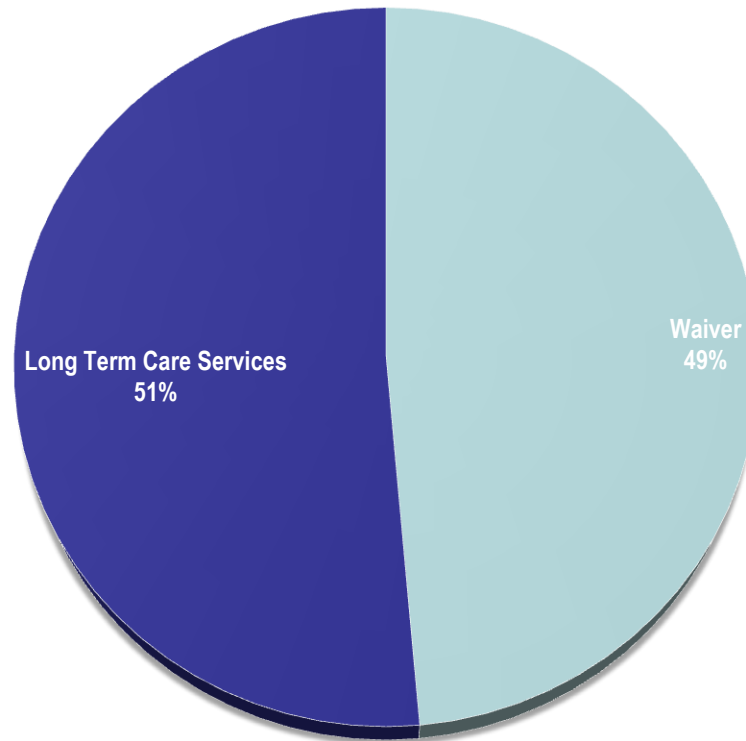
