On behalf of the above-referenced CCRC clients, we hereby submit this written request regarding the applicability of §31-6-47(a)(17) of Senate Bill 433 on these CCRC establishments, which currently operate sheltered nursing facilities. Following is our question:

- I. Will existing CCRCs that have licensed and opened their sheltered nursing facilities, but have not been in operations for five (5) years qualify for the exemption of admitting non-CCRC residents into their sheltered nursing facilities provided under §31-6-47(a)(17)?
  - ✓ Park Springs received a license for its sheltered nursing facility in March 2005. Under SB 433, there remains two (2) years that this Community could admit non-CCRC residents into its sheltered nursing facility.
  - ✓ The Marshes of Skidaway Island received a license for its sheltered nursing facility in March 2006. Under SB 433, there remains three (3) years that this Community could admit non-CCRC residents into its sheltered nursing facility.

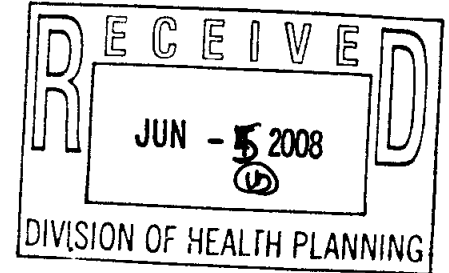

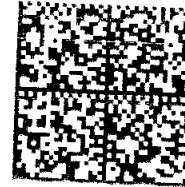

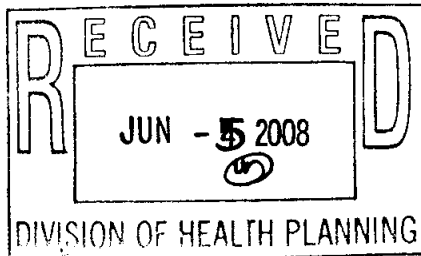
