This is notification that public hospitals will receive a redistribution of overpayments identified in the Independent Verification of the SFY 2018 and SFY 2019 DSH payments performed by Myers and Stauffer. Documents related to the intergovernmental transfer and DSH payment amount for public hospitals will include SFY 2018 and SFY 2019 years.

Information about the schedule, payment and intergovernmental transfer amount are attached and will be available on the Department's web site at www.dch.georgia.gov by selecting options for "Provider," "Provider Types," "Hospital," then "Indigent Care Trust Fund."

Please note that the required intergovernmental transfer must be received by 12 p.m. on April 10, 2023, for a payment to be issued. To assure that the timely receipt of intergovernmental transfers can be confirmed, a Notice of Intent to Transfer form must be submitted by April 3, 2023, to document the expected method of transfer. If an intergovernmental transfer is not received by the specified deadline, the associated DSH payment will be delayed until another date later this year.

The DSH payment will be issued through Georgia Medicaid Management Information System (GAMMIS). The same system that currently processes and pays Georgia Medicaid claims.
