Medical Care Advisory Committee Meeting Wednesday, August 17, 2022 Remote Meeting 2 Peachtree Street Atlanta, Georgia 30303

Minutes

- Greetings and welcome were given to all attending participants at the start of the meeting at 12:30 am.
- Agenda was approved and adopted.
- Minutes from the 1st quarter meeting held on February 16, 2022, were approved by members
- MCAC Officer Nominations Motion approved Chair Dr. Ryan Vaughn/Vice Chair Dr. James Richardson
- MCAC Reappointment & Appointments Dr. Holloway advised letters are forthcoming
- Lynnette Rhodes, DCH Executive Director, reported on the below reports:
 - CMO Procurement: Engaging Stakeholders/RFI (deadline closed) Timeline for RFP January/February 2023.
 - GA Waiver Update: All waivers will remain in place. No changes Currently requesting various flexibility from CMS.

-Engaging in a PR Firm to assist with communication to members and public service announcements.

-Waivers related to Public Health – 1. Extend timeframe/ resolve any fair hearing request. 2. Utilize addresses for members that are maintained by CMO's. 3. Utilize contact information from USPS/National Change of Address Database.

-Given CMS formal notice DCH will transition out of Postpartum 1115 waiver previously announced moving forward with extension to 12 months Postpartum services.

- Public Health Emergency Update: extended to mid-October. Anticipating another extension based upon CMS agreeing to give DCH 60 day notice prior to end of PHE to carry to the end of year 2022
- Fee-For-Service Dental Update: (Clarissa Lewis and Nicole Thompson)
 - results of 2021 audits that stated that DCH compliance with federal standards does not ensure that FFS have sufficient access to dental services.
 - DOAA recommendations
 - 1. Analyze the number of FFS providers who accepts new patients and of participate in Medicaid.

- 2. Measure the ratio of FFS recipients to active providers accepting new patients on a county level.
- 3. Conduct "secret shoppers" calls to determine whether FFS beneficiaries can obtain dental appointments in reasonable timeframe.
- Legislative Update: (Brandy Sylvan)
 - House Bill 1013 Mental Health Bill Requires all plans be in compliance with federal parity law and calls for the creation of a violation complaint repository. Establish parity reporting requirements for DCH plan. Establish a maximum Medical Loss Ratio for CMO contracts. Directs DBHDD to create a multi-agency treatment for children (MATCH) for improved care coordination across agency with complex needs. Directs DCH to conduct a rate study for mental health services. Defines coverage requirements for drugs prescribed for the prevention or treatment of psychotic symptoms under MAP. There are different effective dates for this bill.
 - House Bill 1324 Prudent Layperson Standard requires coverage of emergency care regardless of final diagnosis. Effective Date July 1st, 2022.
 - House Bill 1276 DCH Statistical Reports Requires Bi-Annual reporting of statistical data for DCH plans. Effective Date July 1st, 2022.
 - House Bill 412 Licensure of Applied Behavior Analysts will require system changes to allow for provider enrollment. Effective Date July 1st, 2023
 - House Bill 918 Rare Disease Advisory Council MAP will work with council when considering policy changes regarding rare diseases. Effective Date July 1st, 2022
 - State Plan 338 Postpartum Medical Coverage Extends eligibility for pregnancy Medicaid to 1 year postpartum. Effective Date (Upon approval by CMS)
 - State Plan 341 Medications for Chronic Conditions Requires 12month prior authorizations for medications prescribed for treatment of chronic conditions. Effective Date January 1st, 2023
 - State Plan 610 Provider Rate Study/IMD Waiver Directs DCH to conduct a rate study for waiver services every 4 years. Directs DCH to submit a waiver request to CMS to allow institutes of mental disease to qualify for medical reimbursement. Effective Date December 31st, 2022
 - State Bill 770 Senate Study Committee on IDD and Waiver Access
 creates a study committee to examine IDD waiver access DCH holds a seat on the committee.

- FY 23 DCH budget highlights for MAP
 - 1. Increase funds for implementation of Express Lane Enrollment
 - 2. Eliminate provider attestation requirements to allow all providers to receive enhanced rates for primary care codes.
 - 3. Increase funds to extend postpartum coverage to 12 months
 - 4. Provide funds for value-based purchasing.
 - 5. Provide funds for coverage of therapeutic and care management servicing trails and donor milk
 - 6. Increase reimbursement rates for LTAC's, ventilators, medical nutrition therapy, dental services, independent pharmacy dispensing fees and others.
