Rate Increase for Babies Can't Wait (BCW) Service Coordinators

Babies Can't Wait Service Coordinators provide services to Medicaid and PeachCare for Kids members. Depending on the member's coverage, these services may be reimbursed by the Department of Public Health (DPH) or the Department of Community Health (DCH).

Pursuant to House Bill 68 passed in the 2025 legislative session, DPH increased rates for Service Coordinators. DCH proposes to increase the fee-for-service reimbursement rates for the following BCW codes, effective October 10, 2025.
