



## PUBLIC NOTICE OF PROPOSED RULE CHANGES

Pursuant to the Georgia Administrative Procedures Act, Official Code of Georgia (O.C.G.A.) § 50-13-1, *et seq.*, the Georgia Department of Community Health is required to provide public notice of its intent to adopt, amend, or repeal certain rules other than interpretative rules or general statements of policy. Accordingly, the Department hereby provides notice of its intent to revise its rules and regulations, specifically, Ga. Comp. R. & Regs. r. 111-8-7, Healthcare Facility Regulation, Rules and Regulations for Birth Centers. The proposed rule change reflects an amendment to a rule cited in Ga. Comp. R. & Regs. r. 111-8-7-.22 by deleting a reference to Chapter 111-8-3 which does not presently exist in the rules. This change is being proposed pursuant to the authority granted to the Department of Community Health in O.C.G.A. § 31-2-4 and O.C.G.A. Chapter 31-7, Article 1. An exact copy of the revised rules and a synopsis of the revisions are attached to this public notice.



**SYNOPSIS OF REVISED RULES**

**STATEMENT OF PURPOSE:**

The Georgia Department of Community Health proposes to amend and update the Rules and Regulations for Healthcare Facility Regulation, Rules and Regulations for Birth Centers, Ga. Comp. R. & Regs. r. 111-8-7-.22. This rule is being amended pursuant to the authority granted to the Department of Community Health in O.C.G.A. § 31-2-4 and O.C.G.A. Chapter 31-7, Article 1.

## **Rule 111-8-7-.22 Applicability of Regulations**

These regulations are applicable to any building or facility which is or shall be classified by the Department of Community Health as a birth center and the services provided there in, and expressly do not modify or revoke any of the provisions of the published rules of the Department of Community Health, Chapter 111-8-40 (Rules and Regulations for Hospitals), ~~or of Chapter 111-8-3 (Rules and Regulations for Performance of Abortions After the First Trimester of Pregnancy and Reporting Requirements for all Abortions)~~, or of revisions which may be made to said regulations.
