Michael Smith, Director, Behavioral Health, Medical Assistance Plans presented to the Board for final adoption the Medical Assistance Plans, State Plan Amendment (SPA): Therapeutic Care Model (TCM) Public Notice.

The Therapeutic Care Model (TCM) is a multi-disciplinary, whole-person-centered, and community-based program designed to reduce residential treatment for the state's most vulnerable young people in Medicaid. TCM is also uniquely positioned to shepherd this population through their emerging adulthood into stable and sustainable community placements following system age out or after 21.

The TCM is modular. It contains core components and add-on options. The core and add-on components in the full model will be available in the SPA. Many iterations of the model can be developed and built, depending on the needs of the member and provider community.

Cost Impact

The per diem range for TCM is currently \$213-\$343 per day based on the composition of service package for the member, the level of programming intensity, and their geographic location: urban or rural. Rural per diem rates will be enhanced for rural placements.

Under the amended rules, the owner, administrator and direct care staff of each Adult Residential Mental Health Program licensed by HFRD will require a fingerprint criminal background check.
