The Board of Community Health held its regularly scheduled meeting at the Department of Community Health (DCH), 5th Floor Board Room, 2 Peachtree Street, N.W., Atlanta, Georgia. (An agenda and a List of Attendees are attached hereto and made an official part of these Minutes as Attachments #1 and #2). Chairman Norman Boyd presided and called the meeting to order at 10:30 a.m.

Minutes

Commissioner's Report

Commissioner Berry thanked the Board, members of the public and staff for their attendance.

Commissioner Berry updated the Board on the following:

John Upchurch, Director of Reimbursement presented to the Board for final adoption the Medical Assistance Plans, State Plan Amendment: Medicaid Rate Increase for Nursing Home Mechanized Ventilator Care Programs Public Notice.

Pending final Board and CMS approval, effective July 1, 2019, the Department is proposing a rate increase for specialized nursing home ventilator care. For State Fiscal Year 2020, the General Assembly appropriated funds to increase the nursing facility per diem for a ventilator dependent resident by three percent from \$524.81 to \$540.55.

This change is estimated to increase Medicaid nursing home expenditures for the Aged, Blind and Disabled Program for SFY 2020 by \$109,342 state funds (\$335,200 total funds).

An opportunity for public comment was held on May 15, 2019 at 10:30 a.m., at the Department of Community Health, 2 Peachtree Street, N.W., Atlanta, Georgia 30303 in the 5th Floor Board Room. Written comments were accepted on or before May 22, 2019. No oral comments were received. One written comment was received from Donna Nackers, Vice President of Reimbursement with the Georgia Health Care Association (GHCA).

Ms. Nackers stated the inflationary increase to the payment rate for this specialized program is needed to recognize the rising costs to provide the clinical and equipment services essential for the ventilator dependent patient population. The last increase to the ventilator program rate was granted effective July 1, 2017. GHCA supports the inflationary rate increase. Mr. Upchurch indicated that DCH appreciates the support of GHCA for this action.

Mr. Upchurch respectfully asked for the Board's favorable consideration of final adoption.

Allana Cummings MADE a MOTION to approve for final adoption the Medical Assistance Plans, State Plan Amendment: Medicaid Rate Increase for Nursing Home Mechanized Ventilator Care Programs Public Notice. Russell Crutchfield SECONDED the MOTION. ON THE MOTION, the yeas were 9, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, State Plan Amendment: Medicaid Rate Increase for Nursing Home Mechanized Ventilator Care Programs Public Notice is attached hereto and made an official part of these minutes as Attachment #3).

John Upchurch, Director of Reimbursement presented to the Board for final adoption the Medical Assistance Plans, State Plan Amendment: Hospital Services-Supplemental Payment for Inpatient Services Rendered in Child and Adolescent Behavioral Health Unit Public Notice.

Pending final Board and CMS approval, effective July 1, 2019, the Department proposes to implement a new annual supplemental payment to acute care hospitals that have inpatient child and adolescent behavioral health units. The supplemental payment will provide additional reimbursement to eligible hospitals, bringing the total Medicaid payments for inpatient mental health services rendered by the units to the equivalent of \$750 per covered day.

This proposal would provide additional funding to four hospitals. The impacted hospitals are Donalsonville Hospital, Northeast Georgia Medical Center, Saint Francis Hospital and Tanner Medical Center-Villa Rica. This change is estimated to increase hospital expenditures for SFY 2020 by \$144,005 state funds (\$441,464 total funds). This funding was appropriated by the General Assembly in the State Fiscal Year 2020 appropriations bill.

An opportunity for public comment was held on May 15, 2019 at 11:00 a.m., at the Department of Community Health, 2 Peachtree Street, N.W., Atlanta, Georgia 30303 in the 5th Floor Board Room. Written comments were accepted on or before May 22, 2019. No oral or written comments were received.

Mr. Upchurch respectfully asked for the Board's favorable consideration of final adoption.

Mark Trail MADE a MOTION to approve for final adoption the Medical Assistance Plans, State Plan Amendment: Hospital Services-Supplemental Payment for Inpatient Services Rendered in Child and Adolescent Behavioral Health Unit Public Notice. Kenneth Davis SECONDED the MOTION. ON THE MOTION, the yeas were 8, nays 0, abstained 1, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, State Plan Amendment: Hospital Services-Supplemental Payment for Inpatient Services Rendered in Child and Adolescent Behavioral Health Unit Public Notice is attached hereto and made an official part of these minutes as Attachment #4).

John Upchurch, Director of Reimbursement presented to the Board for final adoption the Medical Assistance Plans, State Plan Amendment: Hospital Services-Extension of the Hospital Provider Payment Program Public Notice.

Pending final Board and CMS approval, effective July 1, 2019, the Department proposes to extend the current Hospital Provider Payment program until June 30, 2025.

This extension was enacted by the Georgia General Assembly in HB 321. This program was initially implemented in 2010 and this will be the 3rd extension of the program. HB 321 made no change to the operation of the program.

The Hospital Provider Payment program is expected to increase hospital expenditures in SFY 2020 by \$113,749,741 state funds (\$348,711,653 total funds).

An opportunity for public comment was held on May 16, 2019 at 10:30 a.m., at the Department of Community Health, 2 Peachtree Street, N.W., Atlanta, Georgia 30303 in the 5th Floor Board Room. Written comments were accepted on or before May 23, 2019. No oral comments were received. One written comment was received from Chris Wilde, EVP Enterprise Chief Financial Officer, Navicent Health.

Mr. Wilde stated that Navicent fully supports the extension of the Hospital Provider Payment Program and the state's efforts to try and more fully compensate those providers who are caring for Medicaid patients. Navicent Health would like the Board to review the methodologies employed in calculating the annual provider fee amounts and the distribution of add-on payments to individual hospitals and the industry as a whole. Navicent Health stated that the program has become skewed in favor of a handful of winners to the detriment of the rest of the hospital community. Navicent Health stated that last year the hospital industry paid in over \$65 million more than it got back in add-on payments. Also, Navicent Health would like there to be greater transparency regarding the number of winners and losers annually.

Mr. Upchurch, in response to the Navicent comment, stated that DCH appreciates Navicent's support of the extension of the Hospital Provider Payment Program. The Department's latest assessment of the amount of provider fees collected versus the amount of provider fees paid back out to the hospital industry via add-on payments reflects the two amounts are within 1% of each other. As it has since the inception of the Hospital Provider Payment Program. The Department will continue to monitor this.

Board member Mark Trail asked if Navicent had suggested specific changes to the Hospital Provider Payment Program and if a change would require action by the General Assembly. Mr. Upchurch responded that Navicent had not suggested any specific change to the program and that changes to the program would not require action by the General Assembly.

The Board asked what comments had been received when the Hospital Provider Payment was last extended in 2017. Mr. Upchurch responded that the Department would retrieve any comments from 2017 and provide those to the Board prior to the July Board meeting.

Roger Folsom MADE a MOTION to approve for final adoption the Medical Assistance Plans, State Plan Amendment: Hospital Services-Extension of the Hospital Provider Payment Program Public Notice. David Crews SECONDED the MOTION. ON THE MOTION, the yeas were 9, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, State Plan Amendment: Hospital Services-Extension of the Hospital Provider Payment Program Public Notice is attached hereto and made an official part of these minutes as Attachment #5).

John Upchurch, Director of Reimbursement presented to the Board for final adoption the Medical Assistance Plans, State Plan Amendment: Disproportionate Share Hospital (DSH) Allocation Methodology Update Public Notice.

Pending final Board and CMS approval, effective July 1, 2019. The current language in the Medicaid State Plan states that the Department will utilize the federal definition of uncompensated care in determining the allocation of the annual DSH allotment to hospitals. The Department proposes to add language to the Medicaid State Plan that specifically defines uncompensated care, rather than referencing federal definitions. The proposed definition to be added to the State Plan is the current definition being utilized by the Department in its DSH allocation methodology and will not result in any change for hospitals. This update is budget neutral.

Russ Childers MADE a MOTION to approve for final adoption the Medical Assistance Plans, State Plan Amendment: Disproportionate Share Hospital (DSH) Allocation Methodology Update Public Notice. Russell Crutchfield SECONDED the MOTION. ON THE MOTION, the yeas were 9, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, State Plan Amendment: Disproportionate Share Hospital (DSH) Allocation Methodology Update Public Notice is attached hereto and made an official part of these minutes as Attachment #6).

John Upchurch, Director of Reimbursement presented to the Board for initial adoption the Medical Assistance Plans, State Plan Amendment: Hospital Services - Per Diem Rate Increase for Swing Beds Public Notice.

Pending final Board and CMS approval, effective July 1, 2019, the Department proposes to increase the prospective per diem rate paid to hospitals for swing bed services from \$145/day to \$295/day.

There are 27 hospitals enrolled in the Swing Bed Program. These are smaller hospitals in areas with limited access to nursing home beds. The projected cost of this increase in SFY 2020 is \$505,855 state funds (\$1,551,062 total funds). The state funds were appropriated in the SFY 2020 Appropriations Act.

Roger Folsom SECONDED the MOTION. ON THE MOTION, the yeas were 9, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, State Plan Amendment: Hospital Services - Per Diem Rate Increase for Swing Beds Public Notice is attached hereto and made an official part of these minutes as Attachment #7).

John Upchurch, Director of Reimbursement presented to the Board for initial adoption the Medical Assistance Plans, State Plan Amendment: Ambulance Upper Payment Limit (UPL) Supplemental Payment Program Public Notice.

Pending CMS approval and effective July 1, 2019, the Department proposes to implement a new Ambulance Upper Payment Limit (UPL) supplemental payment program for ambulance providers that are affiliated with a hospital. Under the program, participating ambulance providers will receive increased Medicaid funding via a lump sum UPL payment twice a year.

Participation in the program is voluntary and dependent upon the ambulance provider securing a commitment from a hospital authority to make an inter-governmental transfer (IGT) of funds to the Department to finance the state share of the ambulance UPL payment. This change is estimated to increase expenditures for SFY 2020 by \$10,845,793 state funds provided thru inter-governmental transfers (IGTs) (\$33,167,563 total funds).

Mark Trail MADE a MOTION to approve for initial adoption the Medical Assistance Plans, State Plan Amendment: Ambulance Upper Payment Limit (UPL) Supplemental Payment Program Public Notice. David Crews SECONDED the MOTION. ON THE MOTION, the yeas were 9, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, State Plan Amendment: Ambulance Upper Payment Limit (UPL) Supplemental Payment Program Public Notice is attached hereto and made an official part of these minutes as Attachment #8).

John Upchurch, Director of Reimbursement presented to the Board for initial adoption the Medical Assistance Plans, State Plan Amendment: Nursing Home Services Rate Increase Public Notice.

Pending CMS approval effective for services provided on or after July 1, 2019 and subject to payment at fee for service rates, the Department proposes to modify and increase the payment for nursing facility services as follows:

- Increase the growth allowance used in the computation of nursing facility per diem rates to 13.37% as an inflationary adjustment and to recognize additional costs for enhanced background checks.
- Increase the maximum reimbursement incentive for nursing facilities with 45% or more Medicaid residents during a quarter with Brief Interview for Mental Status (BIMS) scores of less than or equal to 5 from 4.5% to 5.5%.
- Establish a minimum nursing facility reimbursement per diem rate of \$147.00.

This change is estimated to increase nursing facility expenditures for SFY 2020 by \$16,241,785 state funds (\$49,790,880 total funds).

Roger Folsom SECONDED the MOTION. ON THE MOTION, the yeas were 9, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance

Plans, State Plan Amendment: Nursing Home Services Rate Increase Public Notice is attached hereto and made an official part of these minutes as Attachment #9).

Brian Dowd, Deputy Executive Director, Policy and Provider Services presented to the Board for initial adoption the Medical Assistance Plans, State Plan Amendment: Nursing Home Personal Needs Allowance Rate Increase Public Notice.

Pending final Board approval, effective July 1, 2019, the Department proposes to increase the PNA from \$65 dollars per month to \$70 dollars per month. The increase will impact all Medicaid members in nursing homes as well as those in the hospice program in nursing home settings.

The Department estimates that the total cost of the proposal for SFY 2020 for the Aged, Blind, and Disabled (ABD) Population will be \$401,524 state funds (\$1,230,914 total funds). This increase was authorized and funded by the Georgia General Assembly.

Members who received Social Security Supplemental Income (SSI), will receive an additional \$5 supplement administered by the Department of Human Services. The funding for the additional supplement for Medicaid members receiving SSI was funded by the Georgia General Assembly in the DHS budget.

Catherine Ivy, Deputy Executive Director, Service Delivery and Administration Office presented to the Board for initial adoption the Medical Assistance Plans, Waiver Amendment: New Options Waiver (NOW) and Comprehensive Supports Waiver Program (COMP) Supported Employment for the Developmentally Disabled Rate Increase Public Notice.

Pending final Board and CMS approval, effective July 1, 2019, the amendments to both waiver programs will be required to allow rate increases for the two services. Supported Employment Group and Supported Employment Individual Services, provided as a service option in both waiver programs, were approved for a 10% rate increase by the Georgia General Assembly and included in the State Fiscal Year 2020 Budget approved by Governor Kemp.

DCH and the Department of Behavioral Health and Developmental Disabilities (DBHDD) estimate the total cost of the proposal for SFY 2020 is \$1,237,819.74 state funds (\$3,822,791.03 total funds). DBHDD provides the State Funds Match for these services.

Melanie Simon, Executive Director, Healthcare Facility Regulation presented to the Board for initial adoption the Rules and Regulations for Criminal Background Checks, Chapter 111-8-12. The rules are being proposed pursuant to the authority granted the Department of Community Health in O.C.G.A. § 31-6-21 and O.C.G.A. § 31-6-21.1.

Board members were provided a copy of the synopsis of the proposed rules. During the oral presentation, the following was discussed:

- The rules are necessary to comply with the provisions of Senate Bill 406 from the 2018 Session of the General Assembly which requires fingerprint criminal background checks for owners and direct access employees of certain long-term care facilities.

(A copy of the Rules and Regulations for Criminal Background Checks, Chapter 111-8-12 is attached hereto and made an official part of these minutes as Attachment #13).

Jeff Rickman, Executive Director, State Health Benefit Plan presented to the Board for adoption the State Health Benefit Plan (SHBP) State Employees Plan Employer Contribution Rates Resolution.

The Department of Community Health (DCH) State Health Benefit Plan (SHBP or the Plan) presents each year for the Board's consideration the Resolution entitled State Health Benefit Plan State Employees Plan Employer Contribution Resolution Rates (Employer Contribution Resolution), which will become effective July 1, 2019.

House Bill 31, which provides appropriations for State Fiscal Year 2020, establishes a reduction to the employer contributions to the State Employee Plan from 30.454% to 29.454% of total salaries for State Employees. This change will only apply to State Employers participating in the State Employees Plan.

Mr. Rickman respectfully asked for the Board's favorable consideration of adoption.

Russ Childers MADE a MOTION to approve for adoption the State Health Benefit Plan (SHBP) State Employees Plan Employer Contribution Rates Resolution. Kenneth Davis SECONDED the MOTION. 


