## PUBLIC NOTICE (REVISED)

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health (DCH) is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

## Changes to Hospital Directed Payment Preprint (HDPP) Addition of Free-Standing Pediatric Hospitals

Pending approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health proposes to amend the Medicaid hospital state-directed payment program under managed care, effective July 1, 2025. This amendment would expand eligibility to include Georgia's private, free-standing pediatric hospitals.

Under the current program, private, acute care hospitals are eligible, with the exclusion of general cancer hospitals, free-standing children's hospitals, rehabilitative/psychiatric/long-term acute care hospitals, rural emergency hospitals, geriatric psychiatric hospitals, and critical access hospitals.

This proposed change removes the exclusion for free-standing children's hospitals, thereby allowing them to participate in the Hospital Directed Payment Program (HDPP). The list of excluded providers would be revised slightly to also exclude geriatric psychiatric hospitals.

This change is expected to increase provider funding for pediatric services to the Medicaid population and strengthen support for Georgia's pediatric healthcare workforce.

The program currently provides for the aggregate difference between Medicare reimbursement and Medicaid managed care base payments, with an additional 10% increase on Medicaid managed care base payments for those eligible hospitals in Pool 2 of the Disproportionate Share Hospital (DSH) program.

The following table reflects the updated estimated SFY 2026 payments for participating private hospitals, inclusive of free-standing pediatric hospitals:
