Brian Dowd, Assistant Chief, Medicaid presented to the Board for final adoption the Medical Assistance Plans, Waiver Amendment: Elderly and Disabled (E&D) Waivers, increase Adult Day Health Center Rates and increase Alternative Living Service Providers Rates Public Notice.

An opportunity for public comment was held on June 20, 2018 at 2:30 p.m. at the Department of Community Health (2 Peachtree Street, N.W., Atlanta, Georgia 30303) in the 5th Floor Commissioner's Conference Room. Written comments were accepted on or before July 16, 2018. No oral comments were received. One written comment was received from Vicki Johnson, Chair of the Georgia Council on Aging in support of the proposed rate increases.

Mr. Dowd respectfully asked for the Board's favorable consideration of final adoption.

Mark Trail MADE a MOTION to approve for final adoption the Medical Assistance Plans, Waiver Amendment: Elderly and Disabled (E&D) Waivers, increase Adult Day Health Center Rates and increase Alternative Living Service Providers Rates Public Notice. Allana Cummings SECONDED the MOTION. ON THE MOTION, the yeas were 6, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, Waiver Amendment: Elderly and Disabled (E&D) Waivers, increase Adult Day Health Center Rates and increase Alternative Living Service Providers Rates Public Notice is attached hereto and made an official part of these minutes as Attachment #3).

Andrew Johnson, Deputy Commissioner presented to the Board for final adoption the Medical Assistance Plans, Estate Recovery: Commissioner may waive the first \$25,000 of an estate pursuant to Senate Bill 370 Public Notice.

The rate will be effective on July 1, 2018, upon final Board and Centers for Medicare and Medicaid Services (CMS) approval, pursuant to Senate Bill 370 (SB 370), the Department proposes to allow the Commissioner to waive the first \$25,000 of an estate.

This proposed change is estimated to reduce estate recoveries as follows:

	Annual Recovery	
SFY 2017 Recoveries (Actual)	\$	4,084,082

Federal and State law require the State to recover up to the amount of medical assistance paid on behalf of a member from the member's estate upon their death. The Department's Rules and Regulations mirror the federal and state requirements.

SB 370 amends Article 7 of Chapter 4 of Title 49 of the Official Code of Georgia Annotated. Under current Department of Community Health policy, the Department does not recover from estates valued under \$25,000, but does recover from estates valued over \$25,000.

For example, under current policy an estate that is valued at \$30,000 could be recovered in its entirety, while an estate valued at \$25,000 would not be recovered. This example assumes Medicaid is owed \$30,000 or more, and Medicaid only seeks the amount owed.

To determine the fiscal impact of the proposed legislation, the Department used the previous year's recoveries to determine the overall impact of the bill. This proposal will reduce the amount of recoveries by 15%. This proposal will impact 36% of recovery cases. Because the level of recoveries can vary each year, the actual amount of impact per year cannot readily be determined. The actual fiscal impact could range between \$400,000 to \$1,000,000 per year.

Blake Fulenwider, Deputy Commissioner, Chief, Medical Assistance Plans presented to the Board for initial adoption the Medical Assistance Plans, Medicaid Dental Rate Increase Public Notice.

This item requires Medicare and Medicaid Services (CMS) approval of the proposed Georgia Medicaid Fee Schedule. The current rates for two dental codes are as follows

Procedure Code	Service	Current Rate	Proposed Rate
D2391	Resin-Based Composite – One Surface, Posterior – Primary	\$81.54	\$89.70
D7140	Extract Erupted Tooth/Exposed Root	\$61.67	\$71.30

The Department estimates that the total cost of the proposal for SFY2019 for the Aged, Blind and Disabled Population (ABD) will be \$37,738.19 and for Low Income Medicaid (LIM) will be \$146,909.32. These rates were authorized and funded by the 2018 Georgia General Assembly.

Allana Cummings MADE a MOTION to approve for initial adoption the Medical Assistance Plans, Medicaid Dental Rate Increase Public Notice. Mark Trail SECONDED the MOTION. ON THE MOTION, the yeas were 6, nays 0, abstained 0, and the MOTION was APPROVED. (A copy of the Medical Assistance Plans, Medicaid Dental Rate Increase Public Notice is attached hereto and made an official part of these minutes as Attachment #5).

Mr. Fulenwider then presented to the Board for adoption the Alma Property Transfer Resolution.

The Resolution requests the State Properties Commission to transfer custody of real property located in Alma, Georgia from the State of Georgia, Technical College System of Georgia, (formerly known as the Department of Technical and Adult Education), to the Georgia Department of Community Health.

The property consists of a 0.2576 acre tract located in the City of Alma, Bacon County, Georgia, located at 426 and 428 West 12th Street, Alma, Georgia 31510.

The Department of Community Health began occupying this property in 2001. DCH currently employs 35 staff, with additional space for up to 50 total staff, at the location.

Upon approval by the Board of Community Health, transfer of all custody, possession, interest, and control of said buildings, facilities, and land shall be accomplished in cooperation with the State Properties Commission and by Executive Order.

Russell Crutchfield MADE a MOTION to approve the Alma Property Transfer Resolution. Anthony Williamson SECONDED the MOTION. ON THE MOTION, the yeas were 6, nays 0, abstained 0, and the MOTION was APPROVED.
