

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### Increase Rate for Dental Extraction Codes and Specific Dental Restorative Codes

Pending enactment of HB 911, and approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health (DCH) proposes to increase funds for a ten percent increase for two dental extraction codes and a seven percent increase for seventeen specific dental restorative codes effective July 1, 2022.
