Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

EMERGENCY MEDICAL SERVICES (EMS) AMBULANCE TREATMENT WITHOUT TRANSPORT

Pending approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health (DCH) proposes to increase the reimbursement rate for treatment without transport emergency medical ambulance services from \$30 to \$753.35 effective January 1, 2024.

Emergency medical ambulance treatment without transport refers to the onsite treatment of Medicaid and PeachCare for Kids members by responding emergency medical services personnel that does not involve transporting the member to a healthcare facility for additional assessment and treatment. Only one (1) unit per member per day is reimbursable.
