## ESTABLISH A NEW CATEGORY FOR PAYMENT IN THE RURAL HOSPITAL NEWBORN DELIVERY PROGRAM STATE PLAN AMENDMENT (SPA)

Pursuant to House Bill 68 passed in the 2025 legislative session and pending approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health seeks to add an additional designation and payment for the Rural Hospital Newborn Delivery Program.

Currently under the Medicaid State Plan, Georgia provides an enhanced payment for deliveries in rural settings under the Rural Hospital Newborn Delivery Program. The enhanced payment is designated for newborn deliveries for hospitals in rural counties with populations less than 35,000.

Effective July 1, 2025, the Department seeks CMS approval for an additional designation to provide an enhanced payment to hospitals for newborn deliveries in rural counties having populations between 35,001 and 50,000. The Department seeks to set the Rural Hospital Newborn Delivery Program add-on payment for these hospitals at \$1,500 per delivery.

The cost impact is as follows:
