

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### GRADUATE MEDICAL EDUCATION PAYMENTS FOR COMMUNITY SERVICE BOARDS

Pending Centers for Medicare and Medicaid Services (CMS) approval and effective for services provided on or after July 1, 2019, the Department proposes to make quarterly Graduate Medical Education (GME) payments to Community Service Boards (CSBs) with GME programs that are accredited by the Accreditation Council for Graduate Medical Education (ACGME). The total annual amount of each eligible CSB's GME payments will be calculated as follows:

- (1) Determine the count of residents training at the CSB by post-graduate year.
- (2) Multiply the count of residents in each post-graduate year by the amounts listed in the table below. The amounts listed in the table below are the salary and benefits costs of the residents.

Post-Graduate Year	Resident Salary and Benefits
PGY1	\$86,700
PGY2	\$91,800
PGY3	\$94,800
PGY4	\$98,550

The state funds portion of the GME payments will be funded through an intergovernmental transfer (IGT) of funds from the eligible CSB to the Department. This change is estimated to increase Medicaid expenditures for SFY 2020 as follows:
