Independent Care Waiver Program (ICWP) Renewal and Rate Increase

Pending Centers for Medicare and Medicaid Services' (CMS) approval and effective for services provided on or after July 1, 2021 and subject to payment at fee for service rates, the Department proposes to renew the Independent Care Waiver Program (ICWP) with a 10% rate increase to all services provided through the program.

This change is estimated to increase the ICWP expenditures for SFY 2022 as follows:

The current approved ICWP Medicaid Waiver expires in 2021 and must be renewed by the Centers for Medicare and Medicaid Services (CMS). The Department will request a five-year renewal of the program and proposes no changes to service type, description, or maximum allowable units. The 2021 Georgia General Assembly passed legislation to increase Waiver Program rates by 10% effective July 1, 2021. The increase will affect all services provided through the Waiver Program. DCH proposes to submit the waiver rate increases with the five-year Waiver Renewal request.
