INCREASE THE EXISTING PAYMENT FOR THE RURAL HOSPITAL NEWBORN DELIVERY PROGRAM STATE PLAN AMENDMENT (SPA)

Pursuant to House Bill 68 passed in the 2025 legislative session and pending approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health seeks to increase the rate of the add-on payment for the Rural Hospital Newborn Delivery Program.

Currently under the Medicaid State Plan, Georgia provides an enhanced payment for deliveries in rural settings under the Rural Hospital Newborn Delivery Program. The enhanced payment provides \$1,000 per newborn delivery for hospitals in rural counties having populations less than 35,000. Effective July 1, 2025, the Department seeks CMS approval to increase the add-on payment from \$1,000 to \$3,000 per newborn delivery for hospitals in rural counties having populations less than 35,000.

The cost impact is as follows:
