INCREASE REIMBURSEMENT FOR SPEECH-LANGUAGE PATHOLOGY, AUDIOLOGY, PHYSICAL THERAPY AND OCCUPATIONAL THERAPY

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department of Community Health (DCH) proposes to increase select reimbursement rates for speech-language pathology, audiology, physical therapy, and occupational therapy to eighty-five percent (85%) of 2023 Medicare Part B fee schedule.
