Increase Reimbursement Rates for Neonatologists and Maternal Fetal Medicine Specialists STATE PLAN AMENDMENT (SPA)

Pursuant to House Bill 68 passed in the 2025 legislative session and pending approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health (DCH) proposes to increase the reimbursement rate for Neonatologists and Maternal Fetal Medicine Specialists effective July 1, 2025.
