## LEAD INVESTIGATIONS RATE INCREASE

Pending Centers for Medicare and Medicaid Services (CMS) approval and effective for services provided on or after January 1, 2020, the Department proposes to modify and increase the payment for Lead Investigation services as follows:

- Increase the reimbursement rate for Initial Lead Investigations from \$229.60 to \$964.00.
- Increase the reimbursement rate for Post Hazard Abatement from \$197.34 to \$345.00.

This change is estimated to increase Lead Investigation expenditures for SFY 2020 as follows:
