

Meaningful Use Tip Sheet

DXC Technology (formerly Hewlett Packard Enterprise)

General Tips:

- Check your demographics in GAMMIS before completing your CMS registration.
- Do <u>not</u> modify your federal-level registration with CMS once your state-level registration is in the "pended for review" status unless advised by DCH or DXC.
- Review objectives before submitting your application.

HI-BRIDGE Solutions (formerly GA-HITEC)

General Tips:

- Check your Meaningful Use EHR Dashboard every month to ensure you are meeting all measures.
 - If you are experiencing difficulty meeting your measures, check your Meaningful Use EHR Dashboard every week.
- Take screenshots for Y/N items within the first week of the attestation period.

Clinical Decision Support (CDS): Use CDS to improve performance on high priority health conditions.

- Set up CDS rules and take a screenshot of set-up screen for each rule.
- Enable functionality for drug-drug, drug allergy interaction checks in your EHR.

Patient Specific Education: Use clinically-relevant information from CEHRT to identify patient specific education resources and provide those resources to the patient.

Health Information Exchange (HIE): The eligible professional, eligible hospital or critical access hospital that transitions their patient to (a) another setting of care or provider of care, or (b) refers their patient to another provider of care, must provide a summary care record for each transition of care or referral.

• Identify the five practices where you mostly refer patients and call to set up the HIE with them.

Public Health Reporting: The eligible professional, eligible hospital or critical access hospital must submit electronic public health data from CEHRT, except where prohibited and in accordance with applicable law and practice.

• Request a Syndromic Surveillance letter from the Department of Public Health.



• Submit a letter or email to a professional organization requesting to join their clinical data registry reporting.

Georgia Health Information Network (GaHIN)

GeorgiaDirect: A free email messaging service that lets providers securely send patient health information, such as referrals and reports, to other authorized healthcare professionals and patients.

- Check with your EHR vendor to determine if your technology already includes secure direct messaging exchange.
- HIE is a requirement for Objective 5: The eligible provider who transitions their
 patient to (a) another setting of care or provider of care, or (b) refers their patient to
 another provider of care, must provide a summary of care record for each transition
 of care or referral.
- Visit gahin.org/get-connected to enroll in GeorgiaDirect.
- Visit gahin.org/provider-search for the searchable Georgia provider directory.

Myers and Stauffer Certified Public Accountants (MSLC) General Tips:

- Maintain a copy of the documentation used to complete your application for a minimum of six years from the date you applied for the program.
- Ensure any screen shots used for documentation include the date taken. Screen shots should be taken during your meaningful use period, not during the audit.
- Print/screen shot a copy of the parameters used to generate your patient encounter volume.
- If using group proxy, ensure all group members are included in the patient encounter volume and the data is not limited in any way.
- Ensure your security risk analysis is reviewed and updated every year.
