MODIFY THE REIMBURSEMENT CALCULATION FOR EMERGENCY AMBULANCE SERVICES

Pursuant to House Bill 68 passed in the 2025 legislative session the Department of Community Health (DCH) seeks to modify Medicaid policy to change the reimbursement calculation for Emergency Ambulance Services.

The current reimbursement methodology for Emergency Ambulance Services calculates mileage reimbursement after the initial ten (10) miles of transportation. Historically, the initial 10 miles of transportation was included in the base rate for all transportation. Effective July 1, 2025, DCH will remove the calculation methodology requiring providers to disregard the initial 10 miles of transport as included in the base rate. Providers will calculate miles from the initial point of transport of the member. No modifications to the base rate will be made as part of the policy update.

The cost impact is as follows:
