

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### NURSING HOME MECHANICAL VENTILATOR CARE PROGRAM RATE INCREASE

Pending enactment of HB 911, and approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health (DCH) proposes to increase the mechanical ventilator per diem from \$589.62 per day to \$707.54 per day effective July 1, 2022.

In FY 2010, the Department established a specialized, cost-based, reimbursement rate to pay qualified nursing facilities for the specialized care of ventilator-dependent residents. This was in response to a lack of in-state nursing facility capacity to address the specialized needs of hospital patients considered ventilator-dependent, but no longer requiring acute inpatient care. Ventilator care requires specially trained staff, staffing patterns and high-tech equipment to support the patient.
