

## PUBLIC NOTICE (Revised)

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### NURSING HOME PATIENT DRIVEN PAYMENT MODEL (PDPM)

On October 1, 2019, the Centers for Medicare and Medicaid Services (CMS) replaced its Resource Utilization Group (RUG) based resident classification system with the Patient Driven Payment Model (PDPM) classification system. Due to this change, CMS has indicated to states that they (CMS) will remove elements from the Minimum Data Set (MDS) resident assessment that are not necessary for resident classification under PDPM.

Effective July 1, 2024, the Department will implement PDPM using the nursing acuity component only. The nursing acuity component measures the estimated nursing resource needs a resident may have based on their presenting conditions and functional status.
