

## PUBLIC NOTICE

### INCREASE REIMBURSEMENT FOR SELECT OPTOMETRIC CODES

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department of Community Health (DCH) proposes to increase reimbursement rates for select Optometric codes by 10%.

For FY 2025, the General Assembly through HB916 appropriated total funds of \$1,153,453 (State funds \$392,174) to increase reimbursement rates by ten percent (10%) for the following programs and codes.
