

PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health (DCH) is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

Public Rural Obstetrics (OB) Directed Payment Preprint (DPP)

Pending approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health proposes implementing a new hospital state-directed payment (DPP) program under Medicaid managed care, effective July 1, 2025.

The Department proposes implementing a new Public Rural Obstetrics (OB) Directed Payment Program (DPP) for rural hospitals that deliver babies and provide other obstetric services. The Rural OB DPP payments represent a 182% increase to inpatient and a 222% increase to outpatient managed care base payments, which does not exceed 100% of commercial reimbursement.

The following table reflects estimated SFY 2026 payments under the updated methodology:
