Pending Centers for Medicare and Medicaid Services (CMS) approval and effective July 1, 2020, the Department proposes to implement a new direct payment program for faculty groups in the Medicaid Care Management Organizations (CMOs) program affiliated with teaching hospitals. Under the program, participating physician groups through Medicaid CMOs will receive increased Medicaid funding via an annual lump sum direct payment.

Participation in the program is voluntary and potential funding may be derived by the Medicaid CMO Physician Faculty Group securing a commitment from a hospital authority or governmental entity to make an inter-governmental transfer (IGT) of funds to the Department to finance the state share of direct payment.

This change is estimated to increase expenditures for SFY 2021 as follows:
