MEDICAID NEWBORN DELIVERY ADD-ON FOR RURAL HOSPITALS

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department proposes to increase the add-on payment to hospitals in rural counties (populations less than 35,000) from \$750 for every newborn delivery to \$1,000 for every newborn delivery. The rate increase would be effective for dates of service on or after July 1, 2018.

The proposed \$250 increase to the add-on payment is estimated to increase Medicaid hospital reimbursement for SFY 2019 as follows:
