Department of Community Health, Medical Assistance Plans, Elderly and Disabled (E&D) Waiver Program, Waiver Amendment: Structured Family Caregiving

Pending Centers for Medicare and Medicaid Services (CMS) approval and effective for services provided on or after March 1, 2019 and subject to payment at fee for service rates, the Department proposes to add Structured Family Caregiving service to the Elderly and Disabled Waiver Program known as the Community Care Services Program (CCSP) and the Service Options for Community Resources Program (SOURCE). Structured Family Caregiving service provides support to family caregivers who live with and assist an elderly and/or disabled waiver participant requiring significant assistance with activities of daily living. Eligibility for this service option is contingent on there being a live-in, unpaid family caregiver in the home and an assessed need for a minimum of five hours of personal support service daily. The Structured Family Caregiving service provides ongoing telephonic or electronic support to the family caregiver by a Health Coach and review of daily notes submitted by the caregiver reporting changes or concerns about the elderly and/or disabled adult's condition.

The introduction of the Structured Family Caregiving service represents no fiscal impact to the Waiver Program since the per diem rate represents an offset to the equivalent number of hours of Personal Support Services. The estimate cost of the service is as follows:
