

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### Update Nursing Home Reimbursement Rates to Include Use of the 2021 General and Professional Liability Insurance Costs

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department of Community Health (DCH) proposes to change the funding methodology for the general and professional liability insurance cost center of the nursing home reimbursement rates effective February 1, 2022.

This change is estimated to increase total Medicaid expenditures as follows:

	State Cost	Federal Cost	Total Cost
SFY 2022	\$198,637	\$400,571	\$599,208
SFY 2023	\$476,730	\$961,369	\$1,438,099

Beginning February 1, 2022, the 2021 general and professional liability costs will be used in the reimbursement rate calculation. The cost report year will be updated at a minimum every two (2) years. During the transition year, the Department will apply a hold harmless provision to the nursing home reimbursement rate. The hold harmless provision will be in effect through June 30, 2022.

This public notice is available for review at each county Division of Family and Children Services office. An opportunity for public comment will be held **January 19, 2022 at 10:30 a.m., via Zoom audio**. There will be **no in-person** attendance at the Department of Community Health (DCH).
