

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### HOSPITAL SERVICES

Act 1 of the 2013 Georgia General Assembly, known as the Hospital Medicaid Financing Program Act, added new Article 6C authorizing an additional provider payment program on hospitals, or a subclass of hospitals. Therefore, effective for inpatient and outpatient hospital services provided between July 1, 2013 and June 30, 2017, the Department is proposing to establish supplemental Medicaid payments to recognize inpatient and outpatient hospital services delivered to Medicaid beneficiaries in certain private and non-State government hospitals under the States' Medicaid fee-for-service program. The Medicaid supplemental inpatient and outpatient hospital payments made to private hospitals will also take into account certain specialized services provided to Medicaid beneficiaries such as organ transplants, breast or cancer services, psychiatric services, services with high Medicaid acuity, and telemedicine services. The Medicaid supplemental inpatient and outpatient hospital payments made to non-State government hospitals will also take into account certain specialized services provided to Medicaid beneficiaries such as nursery services and telemedicine services.

This change is estimated to increase expenditures for SFY 2014 as follows:
