The Medicaid Care Management Organizations Act (the "Act") requires the Care Management Organizations (CMOs) to provide a Hospital Statistical and Reimbursement (HS&R) report within 30 (thirty) days upon request of a provider. Specifically, O.C.G.A. 33-21A-11 states:

Upon request by a hospital provider related to a specific fiscal year, a care management organization shall, within 30 days of the request, provide that hospital with an HS&R report for the requested fiscal year. Any care management organization which violates this Code section by not providing the requested report within 30 days shall be subject to a penalty of \$1,000.00 per day, starting on the thirty-first day after the request and continuing until the report is provided. It is the intent of the General Assembly that such penalty be collected by the Department of Community Health and deposited into the Indigent Care Trust Fund created pursuant to Code Section 31-8-152. A care management organization shall not reduce the funding available for health care services for members as a result of payment of such penalties.

Additionally, the CMOs must submit a list of the requested HS&R reports to the Department of Community Health ("the Department" or DCH) no later than thirty days following the calendar quarter period.



As requested by the Department, Myers and Stauffer LC (Myers and Stauffer) tested the information included on the quarterly HS&R reports submitted by the CMOs in response to the Act for the quarter beginning October 1, 2019 and ending December 31, 2019 ("Quarter 4"). We attempted to confirm the information reported by the CMOs to demonstrate their compliance with the HS&R reporting requirements of the Act.

The quarterly HS&R reports submitted to the Department by the CMOs contain the following data: the identification of hospitals that requested HS&R reports including location, name of report requestor, date the HS&R report(s) were requested, the date the CMO released the report to the hospital or requestor, and other related information.

Using the HS&R reports provided by each CMO, we attempted to confirm no less than 53 report requests for each respective CMO. The Methodology section provides an overview of how we analyzed the data on the quarterly reports.



In order to perform this analysis, we utilized the quarterly reports submitted to DCH by each of the CMOs. Amerigroup Community Care (AGP), CareSource (CS), Peach State Health Plan (PSHP), and WellCare of Georgia (WellCare) reports were obtained by accessing their web portals on January 31, 2019. For Quarter 4, 242<sup>1</sup> HS&R reports were reported by the CMOs and can be found in Exhibit B of this report.

In accordance with the confirmation process approved by DCH, Myers and Stauffer requests confirmation of the CMO-reported request and release dates from providers, or their representatives, when the CMO-reported release date is 30 days or greater from the CMO-reported request date. With DCH's approval, HS&R reports were randomly selected for Amerigroup, CareSource, Peach State Health Plan, and WellCare to contact providers for confirmation of the dates reported by the CMOs.

Telephone calls or e-mails regarding 216 HS&R reports were initiated on February 17, 2020 and completed on March 24, 2020. Providers were asked to provide the date they requested the HS&R report and the date the CMO provided notification that the report was available.

A maximum of three attempts per provider were performed in an effort to acquire data for this analysis.

Once the data was collected, we analyzed the results and performed follow-up communication as necessary. Provider responses were compared with the dates reported on each CMO's quarterly report.

The assumptions and limitations summarized below should be noted when reviewing this report.

- Our procedures were not designed to identify instances where a CMO may have failed to include a provider's request for an HS&R report in the CMO's report to DCH. However, had instances occurred where a provider stated they requested an HS&R report from a CMO that was not included in the CMO's report to DCH, Myers and Stauffer would have communicated with the respective CMO to confirm the information obtained from the provider.
- Myers and Stauffer accepted a verbal or an email confirmation for information received from providers.
- If there was a disagreement between the CMO and provider, Myers and Stauffer accepted the documentation submitted by the CMO as confirmation.
- If instances occurred where a provider stated they received a requested HS&R report from a CMO after 20 days and that report was originally excluded from our confirmation process, we would have communicated with the respective CMO to confirm the information obtained from the provider.
- As instructed by the Department, if the due date of the report, 30 days after the report was requested, fell on a Saturday or Sunday, the next business day was assumed to be the due date for purposes of this analysis.



This section provides a summary of our findings.

As illustrated in the table above, we have included the total number of reports each respective CMO reported to the Department for Quarter 4, 2019. The findings indicate for 85.6 percent (185 of 216) of the HS&R reports, the providers were able to confirm the information reported by the CMOs. Providers disagreed with 6.5 percent (14 of 216) of the HS&R reports. Providers were not able to validate CMO reported dates for 7.9 percent (17 of 216) of requests in the sample.

The statistics included in Table II are based on the dates included in this sample. Although the dates given to Myers and Stauffer by the providers were considered in the analysis, documentation provided by the CMOs was used to confirm the dates reported to DCH by the CMOs.





#### **AMERIGROUP**

For Quarter 4, Myers and Stauffer contacted 28 representatives regarding 57 HS&R report requests. We identified 37 HS&R reports released by Amerigroup that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 43 requests. Five providers disagreed with the CMO reported dates for ten report requests. We were unable to confirm four report requests as one provider was deemed unreachable after contact was initiated three times. We identified nine HS&R reports released by Amerigroup that were greater than 30 days. The details of these requests can be found in Exhibit A.

#### CARESOURCE

For Quarter 4, Myers and Stauffer contacted 26 representatives regarding 53 HS&R report requests. We did not identify any HS&R reports released by CareSource that were greater than 30 days. Myers and Stauffer did not identify any HS&R reports released by CareSource that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 50 requests. One provider disagreed with the CMO reported date for one report request. We were unable to confirm two report requests as one provider was deemed unreachable after contact was initiated three times.

#### PEACH STATE HEALTH PLAN

For Quarter 4, Myers and Stauffer contacted 27 representatives regarding 53 HS&R report requests. We did not identify any HS&R reports released by Peach State Health Plan that were greater than 30 days. Myers and Stauffer did not identify any HS&R reports released by Peach State Health Plan that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 50 requests. One provider disagreed with the CMO reported date for one report request. We were unable to confirm two report requests as two providers were deemed unreachable after contact was initiated three times.

#### WELLCARE

For Quarter 4, Myers and Stauffer contacted 28 representatives regarding 53 HS&R report requests. We did not identify any HS&R reports released by WellCare that were greater than 30 days. Myers and Stauffer identified 53 HS&R reports released by WellCare that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 42 requests. One provider disagreed with the CMO reported dates for two report requests. We were unable to confirm nine report requests as four providers were deemed unreachable after contact was initiated three times.



Based on our findings, CareSource, Peach State, and WellCare did not have any cases of late reporting for the quarter beginning October 1, 2019 ending December 31, 2019. However, Amerigroup has nine cases of late reporting.

For the nine cases of late reporting, 598 days were determined to be late. Georgia statute (O.C.G.A.33-21A-11) states, "...Any care management organization which violates this Code section by not providing the requested report within 30 days shall be subject to a penalty of \$1,000.00 per day, starting on the thirty first day after the request and continuing until the report is provided."

Pursuant to the statutory and contractual requirements, DCH may elect to impose a penalty of \$598,000 on Amerigroup.





We make the following recommendations to the Department and Amerigroup based on our findings after analyzing the Quarter 4, 2019 HS&R reports:

- The Department should impose a penalty of 598,000 on Amerigroup for the nine HS&R reports that were not released within 30 days of the report request.
- The Department should require Amerigroup to review their procedures for receiving, releasing, and validating HS&R report requests. Issues identified in this report includes incorrect service and payment dates, missing or invalid data, and failure to include provider requests on the quarterly report.
- Amerigroup should perform a quality review of their HS&R report data prior to submitting to providers.
- Amerigroup should promptly address provider's emails regarding HS&R report requests. We suggest creating a dedicated email box for multiple staff to address the initial HS&R report requests and follow up requests.



# EXHIBIT A - B



Below is a summary of the issues identified during our review of the Hospital Statistical and Reimbursement (HS&R) report submissions. This summary includes provider's responses to our validation process. Please refer to Table III on page 14 for a detailed listing of potential penalties.

Please note Myers and Stauffer corresponded with the Amerigroup and providers in an attempt to resolve any potential issues identified prior to the issuance of this report. With DCH's approval, Amerigroup was asked to provide all outstanding report requests. All requests were fulfilled on or before March 24, 2020.

# AMERIGROUP

 Myers and Stauffer contacted April Williams in order to validate the HS&R report dates for Upson Regional Medical Center from the other CMOs. While she confirmed those dates, she advised that she had not received the requested report from Amerigroup which was sent on December 11, 2019. Below is her response:

"The information is correct with the exception of Amerigroup. I requested it also on 12/11/19 but never received it."

We requested clarification regarding Upson Regional Medical Center's report request. Amerigroup responded by submitting the missing report to the provider on March 13, 2020.

2) Myers and Stauffer contacted Gregory Girad in order to validate the HS&R report dates for DeKalb Medical, DeKalb Medical at Downtown Decatur, and DeKalb Medical from the other CMOs. While he confirmed those dates, he advised that he had not received the requested reports from Amerigroup which was sent on December 3, 2019. Below is his response:

"The only group with N/As, should be Amerigroup. I requested data but never received a response."

We requested clarification regarding DeKalb Medical, DeKalb Medical at Downtown Decatur, and DeKalb Medical at Hillandale's reports. Amerigroup responded by submitting the missing report to the provider on March 20, 2020.

3) Holly A. Bizic requested an HS&R report from Amerigroup on behalf on Northside Hospital-Atlanta, Northside Hospital-Cherokee, and Northside Hospital-Forsyth on December 13, 2019. Amerigroup originally reported January 10, 2020 for the release date. When we contacted her regarding the report request and release dates, she responded with the following:



"All dates are correct with the exception of the Amerigroup report requests for Northside's three facilities sent to them 12/13/2019. These reports were never received and multiple attempts to inquire about them have gone unanswered (see attached correspondence). I have searched my mailbox on the below release date and there were no emails from Amerigroup on that date."

We requested clarification from Amerigroup regarding Northside Hospital-Atlanta, Northside Hospital-Cherokee, and Northside Hospital-Forsyth's reports. Heather Dyke, Amerigroup Compliance Manager, responded with the following:

"The report owner advised that she was unable to locate an original response for the Northside Hospital Atlanta, Cherokee & Forsyth requests from 2/20/2020. We did resend on February 20<sup>th</sup>"

4) Rebecca Kendall requested an HS&R report from Amerigroup on behalf of Phoebe Putney Memorial Hospital & Phoebe Sumter Medical Center on November 14, 2019. Amerigroup reported November 30, 2019 for the release date. When we contacted her regarding the report request and release dates, she responded with the following:

"Amerigroup provided two PSRs with different names and provider numbers but the reports were identical in data. We reached out to them via email with reports sent to show the issue and got no response. The providers were 000001482A and 000001416A."

We requested clarification from Amerigroup regarding Phoebe Putney Memorial Hospital & Phoebe Sumter Medical Center's reports. Amerigroup responded by submitting the missing report to the provider on March 24, 2020.
