The Centers for Medicare & Medicaid Services (CMS) is approving the state's request to renew Georgia's 1915(c) New Options waiver for intellectual/developmental disabilities. The CMS Control Number for the renewal is GA.0175.R07.00 and should be referenced on all future correspondence relating to this waiver renewal.

For this HCBS waiver, you have requested a waiver of 1902(a)(10)(B) of the Social Security Act in order to waive comparability of services. The waiver has been approved for a five-year period with an effective date of November 9, 2022.

This waiver will offer the following supports for waiver participants: Community Living Support- Basis/Extended Services, Prevocational Services, Adult Dental Services, Adult Occupational Therapy Services, Adult Physical Therapy Services, Adult Speech and Language Therapy Services, Nutrition Services, Specialized Medical Equipment, Specialized Medical Supplies, Community Guide services, Financial Support Services, Assistive Technology, Behavioral Supports Services, Community Access services, Environmental Accessibility Adaptation, Individual Directed Goods and Services, Intensive Support Coordination, Interpreter Services, Natural Support Training, Respite, Skilled Nursing Services, Support Coordination, Supported Employment Services, Transition Community Integration Services, Transition Services and Support, Transportation, Vehicle Adaptation.

This approval is subject to your agreement to serve no more individuals than those indicated in "C Factor Estimates" shown in the table above. If the state wishes to serve more individuals or make any other alterations to this waiver, an amendment must be submitted for approval. The state may renew the waiver at the end of the five-year period by providing evidence and documentation of satisfactory performance and oversight.

It is important to note that CMS' approval of this waiver solely addresses the state's compliance with the applicable Medicaid authorities. CMS' approval does not address the state's independent and separate obligations under federal laws including, but not limited to, the Americans with Disabilities Act, Section 504 of the Rehabilitation Act, or the Supreme Court's Olmstead decision. CMS reminds the state that the state must have an approved spending plan in order to use the money realized from section 9817 of the American Rescue Plan (ARP). Approval of this action does not constitute approval of the state's spending plan.
