

## PUBLIC NOTICE (Revised)

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### PSYCHIATRIC RESIDENTIAL TREATMENT FACILITIES (PRTF) RATE METHODOLOGY CHANGE

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department of Community Health (DCH) proposes to adjust Fee-for-Service rates for Psychiatric Residential Treatment Facilities (PRTF), effective September 15, 2023. Rates for all PRTFs will be adjusted to seventy-five percent (75%) of the 2023 Medicare Inpatient Facility Rates. The rate increase will be for both the base rate and the rate for children with a co-occurring diagnosis of autism as identified in claims with an (AU) modifier.
