

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### Adult Day Center Rate Increase Elderly and Disabled Waiver

Pending CMS approval and effective for services provided on or after July 1, 2016 and subject to payment at fee for service rates, the Department is proposing to increase the payment for adult day services provided in the two programs encompassing the Elderly and Disabled Waiver (the Community Care Services Program (CCSP) and Service Options Using Resources in a Community Environment (SOURCE)).

This change is estimated to increase Medicaid expenditures for SFY 2017 as follows:
