TBRA Program Guidance

- To provide short-term rental assistance to individuals with disabilities that are receiving services from the Georgia Money Follows the Person who wish to live in the community
- Eligible referrals through Dept of Aging Services (DAS)
- Exclusively for MFP participants living in a institutional settings who wish to live in community
- Adults 18 to 61 year old
- Extremely low income (30% AMI and below)


