



#### **Vision**

- The Integrated Eligibility System will serve as a single point of entry to allow for seamless eligibility processing for Georgians requesting assistance and support from participating agency processing procedures and workflows.
- Provide a one stop shop for consumers to apply for and manage their benefits through the Internet.



## **Project History**

- Initiated in 2011
- Multi-agency involvement and team
  - DCH, DHS, DPH, DECAL, GTA
- Federal multi-agency involvement
  - CMS, USDA/FNS, ACF, CCIO
- Joint Application Requirements sessions completed in early 2012 with over 750 requirements identified



Due to complexity of project and original ACA mandated time frames, it was broken up into two phases

- Phase 1 update legacy eligibility systems to be minimally compliant with the ACA
  - ✓ Completed October 2013 to April 1, 2014 -
    - Online Applications, combined MA/PCK portal via COMPASS
    - updated systems to use MAGI rules for Medicaid/PCK
    - Accept Federally Facilitated Marketplace referrals
    - Implemented new MAGI renewal processes



- Phase 2 New multi-program/multi-agency system
  - Deloitte Consulting won RFP and signed contract May 1, 2014
  - Replacing:
    - COMPASS Medicaid, Food Stamps, TANF, Child Support online application
    - SUCCESS Legacy Mainframe eligibility system
    - CRS Legacy Client Registration System used by SUCCESS, Child Support and Shines
    - VIDA Maximus' PeachCare for Kids system
  - Key Components
    - Customer centric self service web portal
    - Enterprise Master Person Index (eMPI)
    - Web based worker portal
    - Rules Based Engine



## Georgia Value Based Purchasing: The New CMO Contracts

- What is Value Based Purchasing in the Medicaid Program?
  - An enhanced approach to purchasing and program management that focuses on value over volume. It is part of a comprehensive strategy that aligns incentives for Members, Providers, Suppliers and the State to achieve the program's overarching goals. The impact of initiatives is measured in terms of access, outcomes, quality of care and savings.



## Georgia Value Based Purchasing

- Actuarially sound rates with a 5% withhold
- Must share at least 50% with providers and they may incent members
- 14 Core measures for both GF and GF360
  - Primarily HEDIS measures
- 4 additional measures for GF360
  - Additional measures around operations, care management and behavioral health
