# Integrated Eligibility System (IES)

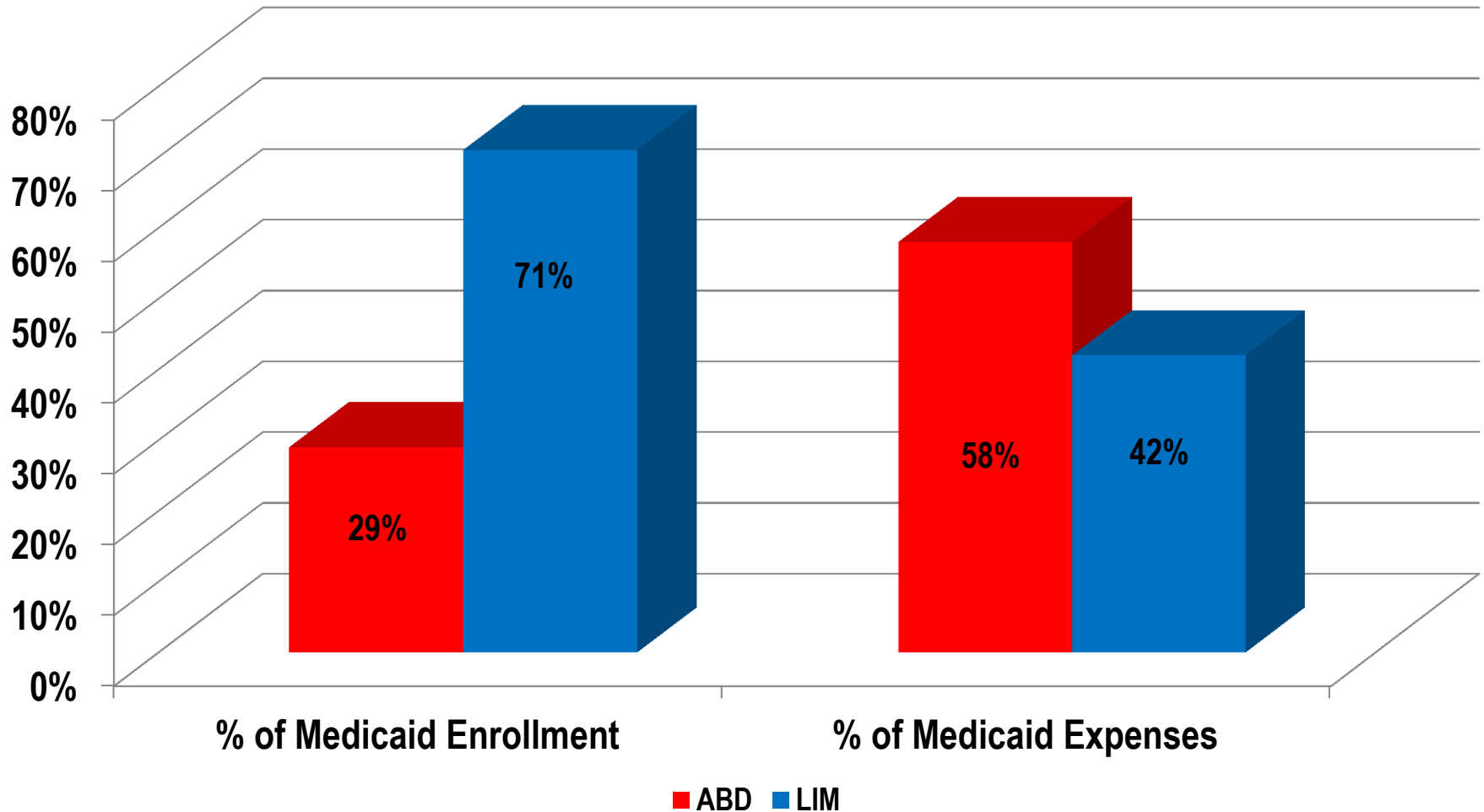
- Current System Antiquated
- Post ACA Enhanced Funding
- Multi-Program Approach
  - Medicaid, TANF, SNAP, WIC, Energy Assistance Program, Subsidized Child Care
- Benefits
  - Self-serve options; Streamlined processes; No wrong Door; Greater automation;

# Georgia Families 360°

- Implemented: March 3, 2014
- Transition ~27K Children to a single, state-wide CMO
- Improve medical oversight
- Better coordinated care
- Increase preventive screening rates
- Establish a Medical and Dental Home
- Appropriate treatment of behavioral health conditions
- Enhance coordination across sister agencies

# ABD Approach

- Care Coordination model for all ABD populations – Live November 2014
- Features:
  - Single statewide vendor
  - Fee-for-Service environment
  - Care coordination, case management, disease management
  - Patient Centered Medical Home
  - Primary Care Case Management Model
  - Provider Engagement
  - Value Based Purchasing

# Legislative Update

- HB 772: Drug testing for applicants for food stamps
- HB 899: Classifies a first conviction of operating an unlicensed personal care home as a felony upon evidence of abuse, neglect or exploitation of residents.
- HB 973: Brings GA False Medicaid Claims Act in line with federal statute.
- SB 352: DCH to establish the Georgia Council on Lupus Education and Awareness



# Legislative Update

- SR 1121: DCH and DPH collaborate and develop strategic action steps to prevent and control diabetes
- SR 1175: Creates a Senate Study Committee to study the provider CMO credentialing application process



# Legislative Update

- Selected Budget Items
  - **Amended SFY14**
    - PIDL savings from Quantity Level Limitation enhancement: \$342K
    - Continuation of P4HB: \$4.1M
  - **SFY2015**
    - Medicaid and PCK Growth: \$40.4M
    - Update to NH 2012 Cost Report: \$13.6M
    - 5% increase for Alternative Living Services, Personal Support Services, and Case Management in E&D Waiver: \$566K
    - Savings from ABD Care Management Program: \$4.2M

# Georgia ACA Impact - Expansion

Projected impact if Georgia had expanded Medicaid (includes non-expansion costs)\*:

	SFY 2014 - 2019	SFY 2014 - 2023
<b>Enrollment</b>	<b>659,372</b>	<b>694,325</b>
<b>Total Cost</b>	<b>\$21.8 Billion</b>	<b>\$40.8 Billion</b>
<b>State Cost</b>	<b>\$1.7 Billion</b>	<b>\$4.5 Billion</b>

*The increased state cost through 2023 is due to the decreased share of federal funds to support Medicaid expansion. In 2014, the federal share is 100% of cost for expansion and declines to 90% by 2020. Assumes 90% through 2023.*

*There are other state costs that do not receive the enhanced 100% FMAP such as the woodwork effect, the impact of moving to 12 month eligibility reviews and the Health Insurer Fee. These are considered non-expansion costs.*

*Based on multi-year projection completed in August 2012.*

# Georgia ACA Impact – Non-Expansion

Projected impact for even though not expanding Medicaid\*:

	SFY 2014 - 2019	SFY 2014 - 2023
<b>Enrollment</b>	<b>110,651</b>	<b>116,423</b>
<b>Total Cost</b>	<b>\$3.6 Billion</b>	<b>\$6.5 Billion</b>
<b>State Cost</b>	<b>\$702.6 Million</b>	<b>\$1.7 Billion</b>

*Based on multi-year projection completed in August 2012.*

- Account Transfers from the Federally Facilitated Marketplace (FFM)
  - 88,584 Accounts
- Transition from 6 to 12 month eligibility reviews
- Hospital Presumptive Eligibility
