Medicaid Rate Setting for Early Intervention Special Instructors Administrative Contract with the Department of Public Health

The Department of Public Health and the Department of Community Health, Medical Assistance Plans (Medicaid and Peachcare), propose to establish a 50 percent Federal Medicaid Funds match on allowable Medicaid-related costs associated with the provision of Babies Can't Wait Special Instruction services (as specified at 34 CFR 303.13b) to support Medicaid beneficiaries receiving Babies Can't Wait Special Instruction Services.

DPH utilizes contracted and employed providers to deliver special instruction services to meet the early intervention needs of children ages 0 to 3 years. The Babies Can't Wait program is administered by DPH in partnership with direct service providers, and is available to Georgians ages 0 to 3 years in need of assistance, including Medicaid beneficiaries.

Special Instruction is provided for infants and children up to age 3 to assess and treat 5 developmental domains. The 5 domains include physical (reaching, rolling, crawling, and walking); cognitive (thinking, learning, solving problems); communication (talking, listening, understanding); social/emotional (playing, feeling secure and happy); and, self-help (eating, dressing). During sessions, Special Instructors work with children (and their families) on behaviors, following directions, attending to tasks, and specific areas of concern for each child.

This change is estimated to increase Medicaid expenditures for SFY 2017 as follows:
