## **PUBLIC NOTICE**

Pursuant to 42 C.F.R. §447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

## Elderly and Disabled Waiver (E&D) Rate Increase and Quality Incentive Program

Effective with an approved amendment by the Centers for Medicare and Medicaid Services and subject to payment at fee-for-service rates, the Department, in response to a joint federal and state initiative to increase access to care, is proposing an increase in rates for Enhanced Case Management, Alternative Living Services, and Personal Support Services. The rate change represents a 6.67% increase. The rate increase for Personal Support Services and Alternative Living Services is funded through the third quarter of SFY 2016 via the Balancing Incentives Payment Program in which Georgia receives an enhanced match to augment home and community based services. There is no state impact until fourth quarter SFY 2016. The rate increase for Enhanced Case Management is funded through a legislative appropriation.

The following rates are proposed to change:

Additionally, a 1%, 2% or 3% provider quality incentive for outcomes achieved by eligible enhanced case management agencies will be assessed to the enhanced case management monthly unit rate for all qualified providers beginning with CMS approval of the waiver amendment. The quality incentive is earned by a combination of measures through which an eligible provider earns points. Provider eligibility is based upon participation in the quality program through administering a customer survey that tracks the measures and attendance to recommended educational and training events. Additional points for Program Measures are earned for the agency's success in limiting nursing facility admissions and keeping the member in the community and in the rate of validated level of care reviews of members for whom the agency submitted application. Finally, a third tier of points may be earned based on the percentage of members who ranked the agency excellent across several domains in the customer satisfaction survey.

A provider is eligible for an incentive based on the following:

- \* To earn the 1% add-on, companies must score 3 points in Part 1: Baseline Measures.
- \* To earn the 2% add-on, companies must score 3 points in Part 1: Baseline Measures PLUS at least 1 point from Part 2: Program Measures.

 To earn the 3% add-on, companies must score 3 points in Part 1: Baseline Measures PLUS at least 1 point from Part 2: Program Measures PLUS at least 7 points from Part 3: Consumer Survey Measures.

This algorithm may be modified for future fiscal years to more accurately reflect the performance and quality provided by the providers.

This change is estimated to increase expenditures as follows:
