

PUBLIC NOTICE

Pursuant to 42 C.F.R. §447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

Elderly and Disabled Waiver (E&D) for Personal Support Services and Personal Support Extended Rates Increase

Effective with an approved waiver amendment by the Centers for Medicare and Medicaid Services and subject to payment at fee-for-service rates, the Department is proposing an increase in rates for Personal Support and Extended Personal Support Services in the two programs authorized through the Elderly and Disabled Waiver, the Community Care Services Program (CCSP) and Service Options Using Resources in a Community Environment (SOURCE).

The following rates are proposed to change:

CCSP	Personal Support Service (Procedure Code T1019)	\$5.05 per 15 minute unit	\$5.07 per 15 minute unit
CCSP	Personal Support Service Ext. (Procedure Code T1019 TF)	\$4.49 per 15 minute unit	\$4.51 per 15 minute unit

This change is estimated to increase expenditures as follows:
