Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

HOSPITAL INPATIENT AND OUTPATIENT UPPER PAYMENT LIMITS

Effective for hospital inpatient and outpatient upper payment limit adjustments made on or after March 12, 2010, the Department of Community Health is proposing to make the following changes to Medicaid inpatient and outpatient upper payment limit (UPL) payments. The purpose of these changes is to more closely align Georgia's upper payment limit calculations with the UPL methods used in other states and recommended by the Centers for Medicare and Medicaid Services (CMS).

These changes should be considered technical in nature and will not require additional State funding since the non-federal share of the hospital UPL program is funded through intergovernmental transfers (IGTs) made by public hospitals and eligible hospital authorities. Changes in both the inpatient and outpatient UPL provide more explicit UPL standards that continue the DCH practice of using the higher of either hospital Medicaid expenditures or Medicare payment amounts in order to establish upper payment limits. The proposed inpatient and outpatient hospital UPL method eliminates the need for retrospective reconciliations with CMS of UPL payments against year-by-year changes in upper payment limits to a prospective method that does not require annual reconciliation adjustments. Since CMS would no longer require these UPL reconciliations, the UPL payment process would be considerably streamlined and could be more quickly adapted to subsequent changes in hospital reimbursement policy.
