Network Access Requirements

Primary Care Providers


- Two (2) within eight (8) miles Urban Areas
- Two (2) within fifteen (15) miles Rural Areas

Specialists

- One (1) within thirty (30) minutes or thirty (30) miles Urban Areas
- One within forty-five (45) minutes or forty-five (45) miles Rural Areas




Number of Counties with 100% Primary Care Physicians Contracted Still Below Benchmark



- *Benchmark = 90%
- •WellCare services 159 counties, 28 fell below the benchmark = 18% of their service area
- •Amerigroup services 159counties, 33 fell below the benchmark = 21% of their service area
- •PSHP services 159 counties, 31 fell below the benchmark =19% of their service area
- •No additional providers exist for recruitment/contracting




Number of Counties with 100% Pediatric Physicians <u>Contracted</u> <u>Still Below Benchmark</u>



- *Benchmark = 90%
- •WellCare services 159 counties, 22 fell below the benchmark = 14% of their service area
- •Amerigroup services 159 counties, 29 fell below the benchmark =18% of their service area
- •PSHP services 159 counties, 31 fell below the benchmark =19% of their service area
- •No additional providers exist for recruitment/contracting



Number of Counties with Zero Access to a Specialist



- •WellCare services 159 counties, 32 have no access to 8 specialty types = 20% of their service area
- •Amerigroup services 159 counties, 27 have no access to 5 specialty types = 17% of their service area
- •PSHP services 159 counties, have no access to 10 specialty types = 21% of their service area
- •No additional providers exist for recruitment/contracting

DCH CMO Centralized Credentialing PHASE I – KEY POINTS

Purpose: Streamline the enrollment application process into the Georgia Medicaid program and implement a single source application to provide credentialing documentation to each of the CMOs.

Who is Eligible?

• New Georgia Medicaid program applicants (i.e. facilities, professional and ancillary providers) who **also** desire CMO network participation.

When will new process start?

1st Quarter 2012



DCH CMO Centralized Credentialing PHASE I – KEY POINTS

What will providers need to do?

- Complete "Request for Network Participation" on specific CMO provider web portal or associated CMO vendor web site
- Follow banner message link to the joint application
- Select specific CMO(s) from list on joint application
- Complete all sections of the joint application
- Attach all current and required documents for enrollment with DCH and CMO



What are the timeframes for DCH enrollment and CMO credentialing?

- Georgia Medicaid ID Number Issuance: 15 days
- Complete Credentialing Process: 30-45 days
 - Submission of an incomplete enrollment application along with missing or outdated credentialing documents may result in a processing delay causing a 60-120 day completion period

How to speed up the process

- Complete all required sections of the joint application
- Submit all requested documents with the initial application request
- Respond promptly to any request for additional information



<u>Is CMO network participation guaranteed?</u>

• No. CMO network participation is based on certain business requirements related to provider type, location and need.

When can providers begin to see members?

• Once the provider has been fully credentialed **and contracted** with the CMO(s). A provider is not a "CMO" network provider until both of the credentialing documents AND the CMO provider contract have been completely processed.

Provider Web Portal

A centralized prior authorization/pre-cert portal for CMO and FFS members

- Will enhance provider access to patients' clinical and claims information
- Improved treatment and outcomes
- Reduced administrative burdens with common portal
 - For Pre-certification/Prior Authorization services
 - Creates a single point of entry to request precertification and prior authorizations from CMO
- Increased transparency of provider benchmarks
 - Access to current individual performance metrics
 - Ability to track and compare metrics among providers across a broad geographic scale
